Y8 Proposed Mathematics trip to Paris, Challenge Week July 2022

Following the success in past years of our regular Mathematics Paris trip, we are proposing to offer another five day trip to Paris during Challenge Week from Monday 04 July to Friday 08 July 2022. This trip is available to all Year 8 students and is an exciting opportunity for your child to take part in a relevant extra-curricular activity.

Why have we chosen this trip?

It is a unique opportunity to experience mathematics abroad and in situ. The tasks and questions are location-based, they show maths in context and they reveal an applicability and relevance of the subject that cannot be realised or achieved within the classroom.

Many mathematics topics will be covered and your child will also be expected to use enterprise skills to solve problems during the trip.

The itinerary

Day 1

Departure from school by coach, travel to Paris via Dover and Calais. There will be mathematical tasks to complete on the journey.

Dinner and overnight stay at a 2* hotel in the Paris outskirts.

Day 2

All day visit to Disneyland Paris – meal included. Mathematical activities - and a chance to have some fun! Seine River Cruise and overnight stay in the hotel.

Day 3

Morning – visit to La Villette City of Science and Mathematics.

Afternoon – various mathematical activities at the following locations: the Arc de Triomphe, the Louvre Pyramid, the Palais Royal Courtyard and the Invalides Gardens.

Dinner in a Paris restaurant.

Evening trip to the Eiffel Tower.

Overnight stay in the hotel.

Day 4

All day visit to Parc Asterix Mathematical activities and even more fun! Dinner and overnight stay in the hotel.

Day 5

Travelling back to Calais, opportunity to shop at Cite d'Europe. Travelling by Eurotunnel/ferry to Folkestone/Dover then onto Horsham.

Costs

The price will include all travel costs, entry fees, one good meal each day, bed and breakfast in the hotel, trip polo shirts and insurance.

This is a residential activity taking place in Challenge Week in July when the regular timetable is suspended. We envisage the cost to be approximately £530 per student (depending on the numbers travelling and the exchange rate) which can be paid in instalments. Payment should be made via your child's ParentPay account (www.parentpay.com). Participation in this trip is voluntary.

I would therefore be grateful if you could complete the attached reply slip and return it to Mrs Dougherty, Main Office with a non-refundable £75 deposit paid via your child's ParentPay account by Friday 22 October 2021 at the latest.

Once I have an indication of numbers, I will write to you again with the exact costs and place a provisional booking.

Behaviour and participation

Please note that the participation of any student who has been excluded is automatically considered at Senior Leadership Team level. Equally, your child may lose their right to be considered for a place by virtue of his behavior record and/or because he represents an unacceptable risk to the trip organiser, other students or himself. When such a situation arises, each student is considered on an individual basis, and our judgment as to whether the trip is an essential element of the exam or course requirements, the student's individual circumstances, the nature, length and frequency of their exclusions and the potential risk they represent to the trip organizer, other students and themselves. The school reserve the right to withdraw a child from a trip for safeguarding purposes at any time, and we cannot guarantee that any monies paid will be refunded.

Payment terms

Initial Deposits are non-refundable for all trips. All payments made after the deposit will only be refunded if a medical exception is received and we can claim the money back from our insurers. Trips not paid in full before the date required may not be guaranteed a place. We are unable to transfer money to other trips should your child not wish to attend for any reason other than medical grounds.

Personal and medical details

Please assist us to keep your child's records up to date by informing us of any changes to your child's personal or medical information, including parent/carer contact details at your earliest convenience.

Parent/Carer commitment
